NOTICE TO INTERNET RETAILERS AND DISTRIBUTORS
CALIFORNIA PROPOSITION 65

1. Notice

Ms. Carita SafeTruck, Inc. and its parents, subsidiaries, affiliates or divisions (collectively “**Ms. Carita**”) are providing you with this notice (“Notice”) that the following products contained in shipments or deliveries from Ms. Carita bear an on-product warning pursuant to California’s Safe Drinking Water and Toxic Enforcement Act of 1986, Cal. Health & Safety Code section 25249.5, *et seq.* (“Prop. 65”), and its corresponding “Clear and Reasonable Warning” regulations, 27 CCR § 25601 *et seq.* (“Prop. 65 Regulations”) because they may contain one or more chemicals on the Prop. 65 chemical list:

- OD Signs and Banners
- Safety Flags
- Safety Lighting
- Safety Accessories
- Safety Clothing
- Tools & Hardware
- Placards

2. Applicable Warning

The on-Product warnings provide as follows:

- (“Applicable Warning”).

3. Internet Warning Requirement

For any Products sold on the internet to California consumers by you or your downstream distributors, customers, retailers (collectively, “Downstream Entities”), please be advised that Prop. 65 imposes certain requirements on websites of internet retailers. You and the Downstream Entities must provide an internet warning consistent with the warning provided on the Product label by either including the warning itself or a clearly marked hyperlink using the word “**WARNING**” on the Product display page with a link to the warning, or by otherwise prominently displaying the warning to the purchaser prior to purchase. The warning provided on the website must use the same warning language as that found on the Products. Please be

advised that internet warnings are not compliant with Prop. 65 if a purchaser must search for the warning in the general content of the website. **Accordingly, please provide the Applicable Warning in this manner as to all Products sold to California consumers over the internet.**

We urge you to familiarize yourself with Prop. 65 and the Prop. 65 Regulations to ensure compliance. Failure to abide by this Notice may void any Prop. 65 indemnity, defense, hold harmless, or other obligations owed by Ms. Carita. Ms. Carita reserves the right to seek indemnity and defense from you for alleged or actual Prop. 65 liability due to any non-compliance with this Notice.

4. Duty to Notify Downstream Entities

If you sell any Products to Downstream Entities (such as distributors rather than end users), you must provide this Notice and obtain a Confirmation of Receipt in accordance with Section 5. If you sell exclusively to end users, you may disregard this Section 4.

5. Confirmation of Receipt

Please confirm receipt of this notice within thirty (30) days of receiving it either electronically or in the mail, by filling out the acknowledgment below and returning a signed copy, to acknowledge that you have received and will abide by this Notice and that the warnings for internet sales will be posted in accordance with this Notice.
